### CIRCULAR

In view of the directions of the Hon'ble Supreme Court of India in the matter of "*University of Kerala v/s. Council, Principals, Colleges and others*" in SLP No. 24295/2006 dated 16-05-2007 and in Civil Appeal No. 887/2009, dated 08-05-2009; and the UGC's "*Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009*", to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students.
