1. PURPOSE OF THE MOU

Any amendments or addendums shall be made in writing and signed by both Parties.

Any dispute arising under this MoU shall be resolved amicably between the Parties. Failing resolution, the dispute shall fall under the jurisdiction of courts in Raipur, Chhattisgarh.
