WHEREAS:

D) Evershine Business Ventures pvt ltd ,the Second Party is engaged water and waste water management and are looking forward for candidates who can be a part of the organization for its sales / Service and marketing activities .



NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2: SCOPE OF THE MoU

2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. This will provide confidence & smooth transition for students work. Also, the Second party may register on the AICTE Internship Portal for the benefit of students.

2.2 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in-house requirements.

2.3 Placement of trained students: Second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in-house requirements.

2.4 There is no financial commitment on the part of the MATS University, Raipur the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.



2.5 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

CLAUSE 3: VALIDITY

3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms.

CLAUSE 4: RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.

4.2 Nothing in this MOU shall be given effect to or bind the signatories contrary to or beyond the provisions of CG act no 29 of 2006, or the statutes and ordinances framed there in by or for MATS University or rules, regulations or directions of state government, PURC UGC or any other regulatory body having authority in MATS University. This MOU details the modalities and general conditions regarding collaboration between MATS University, Raipur and Evershine Business ventures pvt ltd for enhancing, within the country, the availability of highly qualified manpower in the fields of training and MATS University, Raipur and Evershine business ventures pvt ltd **without** any disregard to any mechanism evolved and approved by the competent authorities under Govt. of India in so far as such mechanism applies to MATS University and Evershine . The areas of cooperation can be extended through mutual consent.
