MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as "MOU") is duly made and entered at Raipur on this the 14th of July, Two Thousand and Twenty-Three (hereinafter referred to as the "Effective Date"). This MOU sets for the terms and understanding between MATS University in Chhattisgarh, Aarang – Kharora (hereinafter referred to as "University") and Justice Ventures India Trust (hereinafter referred to as "Organization")

Between

MATS University in Chhattisgarh, having its office at MATS Tower , Pagaria Complex , Pandri , Raipur (Cg) represented duly through its authorised signatory Mr.Gokulananda Panda s/oShri Kishore Chandra Panda(which expression shall unless repugnant to the context or meaning thereof, be deemed to mean and include its representatives, legal heirs, executors, successors in title and assigns, etc.) of the **FIRST PART**

And

Justice Ventures India Trust, having its office at P.O. Box: 3201, Nizamuddin East, New Delhi 110013, represented duly through its duly Authorised Signatory Mr. Prem Raaj, S/o Late Mr. Kishore Raaj (which expression shall unless repugnant to the context or meaning thereof, be deemed to mean and include its successors in title and assigns, etc.) of the

University and Organisation shall herein be collectively referred to as "Parties" and singularly as a "Party".

WHEREAS the above two Institutions have agreed to enter into this non –binding memorandum of understanding (the “MOU”) that enables them to work mutually in the pursuit of the objectives set out herein.

Organisation background

Justice Ventures India Trust (JVIT) is a partnership organization which partners with local organizations and global stakeholders to bring freedom, justice, and restoration to men, women, and children suffering from human trafficking and other forms of extreme injustice. Through partnership, it secures justice for individuals, strengthens local organizations, and improves justice systems.

WHEREAS, both parties share a common goal of combating human trafficking through training and awareness programs; and

WHEREAS, the parties have agreed to enter into a partnership to develop and implement a training and awareness program on human trafficking; and

WHEREAS, the parties wish to define the terms and conditions of this partnership;

NOW, THEREFORE, the parties agree as follows:

I. PURPOSE AND SCOPE

The purpose of this MOU is to establish a partnership between the University and the Organization to develop and implement a training and awareness program on human trafficking.

II. RESPONSIBILITIES UNDER THE MOU:-

The university agrees to fulfil the following responsibilities:

- a. Implementation of Program activities, including but not limited to, training sessions, workshops, webinars, and awareness campaigns.
- b. Identification of the Target Audience and outreach efforts to engage them.
- c. Provide the necessary venue, equipment, and materials to conduct the training and awareness program.
- d. Provide the necessary logistics support to ensure the success of the training and awareness program.
- e. Provide support in the promotion and spreading of the training and awareness program.

The Organisation agrees to fulfil on the following responsibilities:

- a. Development of Program materials, including but not limited to, curriculum, training manuals, handouts, and presentations on human trafficking.
- b. Work in close collaboration with the University in the design, development, and implementation of the training and awareness program.
- c. Provide qualified trainers and resource persons to conduct the training and awareness program.
- d. Provide the necessary support in the promotion and spreading of the training and awareness program.
- e. Evaluation of Program effectiveness, including feedback from the Target Audience and analysis of Program outcomes.

TERM This MOU shall be effective from the Effective Date and shall remain in force for a period of One (1) year. Either party may terminate this MOU upon thirty (30) days written notice to the other party.

Changes may be made to the current Memorandum of Understand by way on a written addendum.

CONFIDENTIALITY The parties agree to maintain the confidentiality of any information exchanged between them in connection with this MOU. Breach of confidentiality may lead to termination of the said MoU.
