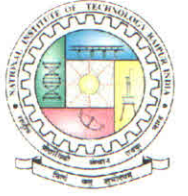

This MoU will enable the parties to undertake the following on mutual agreement:

UNDERTAKE

Research **Collaboration, Projects, Training & Development** between MATS University Raipur and NITRR.

STRENGTHEN the innovative capacity of NITRR and advance industry-driven research and innovation.

SET the ground for short-term University - Institute **participation** in the State of Chhattisgarh.

FACILITATE **addressing** research project by the University for NITRR.

ARTICLE I: BACKGROUND

This MoU will be executed as part of Research Collaboration and also for addressing the Industrial project generated for the students researchers at NITRR.

Such a collaborative program and consultancy is aimed at supporting MATS University Raipur-NITRR research collaboration projects in any scientific discipline and field of application related activities at NITRR. A key outcome for this MOU will make available new knowledge for the larger interest of the society. This collaborative research mode shall also help in understanding research needs of the industry and thus shall provide key inputs for the academia in NITRR to formulate new industry oriented projects and expand the scope of research in any domain handled by any faculty of NITRR.

ARTICLE II: SCOPE OF THE COLLABORATION

The general purpose of this MOU is to facilitate research cooperation between the parties here under based upon the principles of mutual benefit and may include the following general cooperation areas:

- 1.1 Research and training activities.
- 1.2 Exchange of visiting experts for the purpose of conducting research.

ARTICLE III: THE AGREEMENT

- 2.1 At MATS University Raipur, this MOU will be administered by Vice Chancellor. At National Institute of Technology (NITRR), this MOU will be administered by Director or his/her authorized representative.
- 2.2 The parties may enter into specific written agreements under authority of this MOU to clarify and define the nature, extent and terms of operation for the proposed collaborations, including intellectual property ownership and funding issues. However, it is made clear that this MOU does not authorize any party to make any financial commitment, unless it is supported by specific approval of the competent authority of each party with MOU on case to case basis.

- 3.4 Termination of agreement could be done by either side after giving one-month advance notice.

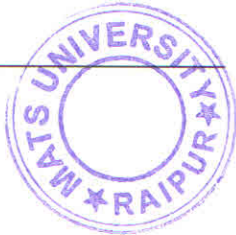



