- For the preparation of SSR, following has been done by the respective criteria:
 - **4** Comparison of AQARs for the last 4 years.
 - ₩ Write-Up of AQARs is on going: expected to be completed by next week.

Criterion II work is pending in this regard. It has been instructed by Registrar Sir to complete the same at the earliest and submit the review/problems faced by Criterion II Owners/Members on or before 15.02.2023 (Wednesday).

- The deficiencies faced during preparation of SSR data was discussed and the following has been suggested by Registrar Sir:
 - To conduct departmental audits by the respective Criteria Owners and Members for the data of the supporting documents which are not present in previously submitted AQARs.
 - **4** To complete the remaining work of SSR data including preliminary write-ups.
- The work for AQAR 2022 23 will also be started alongside SSR.
- For bifurcation of Budget Heads, Criteria III and VI Owners have been asked to submit a list of Heads required from their end and submit it to Registrar's Office for further process.
- A schedule for departmental audit to be made and submitted for approval including visit to departments of Aarang campus by Criterion I and also by other criteria, if required
- The Committee for NAAC AQAR/SSR to be reviewed and recommendations to be sent by Dean (Academics) Madam for further approval.
- The schedule of next meeting with the agenda will be intimated in due course of time.
